1. The supplier and Organiser of the Festival is Nearwater Events a trading name of Nearwater Walking Holidays Limited (Company Number 07444234) whose address is: Nearwater, Polvarth Road, St Mawes, Truro TR2 5AY. The following terms and conditions form the basis of a contract with you the client once the client has completed the booking form and returned it to us together with the relevant booking fee and we have acknowledged acceptance to you in writing or by email.

2. The price of the Festival

The price of the festival is £625 per person. This price is based on two people sharing a car. There is a £100 single supplement. The tour price does not include accommodation and this must be booked independently. The recommended Hotel is the Tresanton (www.tresanton.com) in St Mawes (01326 270053) security will be provided for cars parked in the Hotel car park overnight.

Please note drinks at meals are not included unless specifically mentioned in the itinerary.

3. Payment schedule and method of payment

A deposit of £200 per person is required together with a completed booking form. 4.. Cancellation by you

All cancellations must be in writing and are subject to the following cancellation charges based on total invoice cost:

More than 28 days (4 weeks) Deposit only

Within 28 days (4 weeks) 50%

The cancellation period will be calculated from the date we receive written notice to the date the tour starts. 5. Cancellation by us.
